ILCEIN: "The consumer was provided with a 22' Q-Ramp through United Way of Whitewater Valley grant money. The consumer is 86 years old and she lives with her grandson. In October 2020 she suddenly became very ill and had to have emergency gastrointestinal surgery that left her very weak and unable to walk without the assistance of a walker. At times she also has to use a wheelchair. Because of these health issues, she was unable to manage the steps to get in and out of her home. The consumer was very appreciative of the Q-Ramp that was provided to her by ILCEIN and the United Way. She stated that it was just wonderful to be able to get out whenever she wanted. She no longer feels as though she is home-bound or a burden to her family."
